

It is our aspiration to see the people amongst the poorest regions of rural India receive basic healthcare and for each child to receive a free education. It is our deep-rooted desire to break the chains of poverty and to deliver these people out of such dire circumstances. We offer them the ability to live a life free of sickness, and allow them the chance to not only hope for a better future, but to actively reach it.

We are immensely humbled and gratified by the work and effort our teams have tirelessly put in to see this dream come to fruition. It is through our personal relationships with local institutions that we are able to become intimate with the needs and hardships of these communities, and bring about real change that drastically transforms the lives of countless men. women and children.

#### Donations

The crux of the matter is that we would not be able to accomplish all that we achieve without the immense generosity of our Donors. Without you, we would not be able to offer the support and life-altering change these people so desperately need. We want to offer our deepest thanks and gratitude towards each and every person that has contributed and continuously supported our efforts. Your contributions matter greatly, as every dollar raised has the power to completely alter the trajectory of someone's life and their future.

We are delighted to announce that this year's total donations amassed to over \$952,000. This is an incredible feat considering the lingering impact of the global pandemic, and will aid us greatly in bringing about true change in these regions.

We take every contribution seriously and in order to maximise the capability of the funds, we apply a vigorous process to the management of this Trust so that the money raised reaches the people that need it most. I am exceedingly proud to verify that over 99% of all donations are directly proceeding to the causes we support. Our extensively efficient model results is minimal administration costs as well as zero capital wastage.

#### Activities Funded

The Deepavali Trust continues to support a growing number of hospitals across Uttar Pradesh, as well as the Jagadguru Kripalu Parishat (JKP) education joint venture.

#### **KEY STATISTICS**

Incorporating the efforts of both our hospitals and medical practitioners, we treat around 40,000 patients each month across our Trust-funded healthcare services. Due to the numerous breakouts of Covid-19 variants, our focus has been increasing on improving alternative assistance to the local communities via direct donations to local villagers and their families. Furthermore, in the past we have made the donation to JKP Bhakti Dham Hospital Fund who, due to the major medical/humanitarian crises, supported the Prime Minister's COVID-19 Relief Fund. The Trust provides both schooling and education to approximately 3,660 young girls. Unfortunately, the Global Covid-19 Pandemic has also impacted the school by forcing a temporary reduction of services and access to the school premises from time to time when regional authorities believe the infection rates are reduced to a level that students are able to return to their schooling. We continue to provide not only an opportunity to learn and develop new skill sets, but also a safe environment for these children to flourish, play and grow into their fullest potential. It is only through our joint efforts that we are able to let these children dream of any future for themselves and give them the key to access a better life.

#### Transparency

To ensure the Trust is run with total and complete transparency, external auditor PricewaterhouseCoopers has completed an audit of the Trust's financial statements.

#### Summary

The Deepavali Charitable Trust wholeheartedly views the right to an education as well as safe access to basic healthcare as a God-given right to every human being. No man, woman or child should be left to their hardships, or to suffer needlessly, when we have the power to do something about it. The Deepavali family is dedicated to delivering those less fortunate out of their difficult circumstances, and offer them the help they so desperately need. Our direct focus in helping the communities amongst the poorest regions of rural India is to deliver change via education and medical treatments. Being directly involved with those at the source of the hardship allows us to intimately understand what the need is, and how we are able to offer the solution. Our meaningful local partnerships are a tool that we utilise in order to deploy our resources with absolute effect. 



We strive to open the door to a better life to as many children that we can reach. We lead them to a brighter future by giving them access to an education and a safe environment where they can learn, flourish, play, and just be a child unburdened by the strains of poverty. Our mission is to give these children a better chance in life, that they wouldn't normally have without your help.

#### OUR VISION

To ensure we achieve the greatest impact, we have designed and developed a highly efficient funding model, which ensures the In order to ensure we accomplish the greatest impact, we have formulated and cultivated an extremely efficient funding model that ensures the maximum amount of funds raised reaches the people that need it most. We work intimately with local institutions and partnerships to better understand the difficulties and hardships these communities face, and deploy resources with precision. We have seen first-hand how our efforts have positively impacted individuals, families and whole communities:

- Providing relief from poverty, hunger, the devastation from war and natural disasters.
- Remarkably improving their health standards, life expectancy, and quality of life.
- Opportunities for a better life that comes from education. Children shedding the barriers of illiteracy and having the chance to break free from the poverty-cycle.

#### OUR DEDICATION

We would like to take this opportunity to express our immeasurable gratitude to our teams and charitable partners. Without your generosity, tireless efforts, and unwavering dedication, we would not be able to change the lives of so many. Our unshakeable drive has been delivering free medical care and education to the least fortunate communities across the Indian state of Uttar Pradesh. Every single dollar raised and deployed has the promise to fundamentally alter the lives of hundreds and thousands of people.

#### CHARITABLE HOSPITALS

Since our humble beginnings, we have grown exponentially in our ability to assist and connect with those who have been plagued by poverty. To put this into perspective, pre-Covid we were treating up to 40,000 patients each month. Our operations take place across three hospitals, with the assistance from local charitable institutions to deliver cost-free healthcare, ending the unnecessary agony of thousands caused by a lack of basic treatment and medications.

It is our fundamental belief that access to basic healthcare should be recognised as a Human Right. For what is life, if we do not have the ability to take care of ourselves and our families. For so many of the people of Uttar Pradesh, this is the harsh reality they face every single day.

It is through our sponsored programmes that we are able to offer a different path for these people. We provide both preventative and reactive treatments and services for patients, as well as utilise local knowledge and partnerships to supply the correct health response to each local community, such as:

- Treatment of varying degrees of burns obtained from local cooking methods.
- Care for wounds, injuries, abrasions and bacterial infections caused from unsanitary conditions, animal/insect bites
  and rusted tools.
- Women's Gynaecological and Health Issues, especially those related with traditional village birth.
- Common illnesses within the region, like that of typhoid, malaria and dysentery.
- Viral breakouts, including respiratory tract infections.

Without access to these critical medical treatments, thousands of impoverished men, women and children would tragically die or s uffer unnecessarily.

#### FREE EDUCATION

"Education is for improving the lives of others and for leaving your community and world better than you found it." - Marian Wright Edelman

Being a father has only opened my eyes to the necessity and importance of my children's education, and ultimately their aspiration of obtaining a life greater than the one they were born into. It is my belief that this is a God-given right, and to see this right taken away from millions of children, particularly for girls in the state of Uttar Pradesh, is an injustice that needs to be remedied. These innocent young girls are forced into manual labour or a life of domestic servitude, and tragically, many are taken as child brides.

The most effective tool we can give to these children is an education. Pursuit of knowledge and continual learning is the key that will unshackle them from this unfair burden, setting them free from illiteracy and destitution. We open the door for these children to enter a world where they can be children again. Where they can play and learn in a safe environment, develop new skillsets, and know that any possibility for their future is available to them. That no dream is too big or too far out of reach.

We provide education, 100% free-of-charge, to over 4.400 girls aged from kindergarten through to secondary school. It is our hope that as these young girls grow from childhood to womanhood, that we can empower them with the belief that they are strong, intelligent and capable women with the ability to transform their homes and communities, breaking free from the cycle of poverty.

We are providing these children with the ability to gain economic independence and learn the tools necessary to create a better life for themselves. In doing so, we are aiding in the collective elevation of the entire community.

We are exceedingly gratified and fulfilled by the all the work we have completed to date, as we have witnessed the substantial, life-altering progress for the people he have been fortunate enough to aid. While we rejoice over all that has been accomplished, we are by no means done. We are continuously renewing our efforts with gusto in order to reach our expanding goals to bring tangible change to the millions of people still in dire situations. We share this precious life with them, and it is our duty to do all we can to serve one another.ever, our work is by no means complete, and our efforts must be continued with vigour if we are to reach

our goals in bringing real change to the millions of less-fortunate people that we share this precious life with.

#### COVID 19 UPDATE

The Covid-19 pandemic has undeniably impacted everyone's lives across the globe. Under these circumstances, we had to rapidly adapt and adjust to the resulting restrictions to ensure that we could continue be of value to the communities and local institutions we aid. This meant that for health and safety reasons, we had to operate the schools at slightly limited capacity to constrain the spread of the virus and protect the Students and Teachers.

#### ENTITY STRUCTURE

Our Trust Deed mandates that we must have between three and five Trustees. We currently have three Trustees that constitute our Governance Board.

#### OPERATIONAL STRUCTURE

The Deepavali Charitable Trust's operations are overseen by a team of three unpaid volunteers, who are supported by many other unpaid volunteers throughout the year. Not a single member is paid for the day-to-day running and administration of the Trust, as our goal is to maximise the funds available for those who need it most.

#### DELIVERY OF HUMANITARIAN SERVICE

Deepavali has meticulously recruited a selective number of reputable partners in India to deploy our humanitarian services. One specific partner is the Indian based charity, Jagadguru Kripalu Parishat ("JKP"), which has an extensive logistical and professional doctors' network which allows Deepavali to achieve our vision effectively and efficiently. JKP continues to outshine and demonstrate its value as an instrumental partner across both our education and health related services.

#### MAIN SOURCES OF THE ENTITY'S CASH AND RESOURCES

Deepavali has been fortunate to fund its activities from the generous donations received from the New Zealand public, mainly individuals, and some private companies. Our ability to obtain the support from large-scale donors remains crucial to maintaining the current scale of our charitable work. Fresh sources of corporate donations have been a key focus in recent years.

#### MAIN METHODS USED BY THE ENTITY TO RAISE FUNDS

Our primary tool for active fundraising is specific and personalised one-on-one presentations to prospective donors. It is important to our donors that we make the most efficient use of funds available and therefore we do not use any third-party organisations for fundraising, as they typically have high fee structures.

Deepavali is an extremely attractive charity for our donors due to our exemplary operating efficiencies and complete operational transparency.

#### **OPERATING EFFICIENCY**

No Administrative and management overheads.

Every single in-house doctor, nurse, administrator, and support staff are made up of volunteers who desire to make a difference and be a positive impact on the communities and individuals we serve. While we do occasionally pay for some external professional staff where there are shortages in our volunteer pool, like teachers and specialist doctors, these professionals are directly delivering service to the less fortunate. In other words, it is safe to say that a donor receives the best return for their donations when contributing to our charities.

#### **OPERATING TRANSPARENCY**

We're open to visitors.

Whether you are actively considering donating, or an already pre-existing donor, you are always more than welcome to come visit and spend time in our facilities. We highly encourage and actively support donors who wish to visit our facilities, so that they are able to see for themselves how their funds are directly being utilised to serve the underprivileged.

#### MAIN METHODS USED BY THE ENTITY TO RAISE FUNDS

Deepavali Charitable Trust is fully staffed by volunteers. No Trustee or administration staff are paid or remunerated in any way.

## STATEMENT OF ACCOUNTING POLICIES

### Year ended 31 March 2022

#### **Basis of Preparation**

Deepavali Charitable Trust (the "Trust") has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the statement of financial performance are reported ususing the accrual basis of accounting. The financial statements are prepared under the assumption that the Trust will continue to operate in the foreseeable future.

#### Goods and Services Tax (GST)

The Trust is not registered for GST. Therefore amounts recorded in the statement of financial performance are inclusive of GST (if any).

#### Income Tax

The Trust is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### Bank Accounts and Cash

Bank accounts and cash in the statement of cash flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

#### Donations and Grants

The Trustees have elected to apply the Tier 3 reporting standards as specified by the Charities Service and the External Reporting Board. Revenue for donations and grants are recognised once the Trust receives cash. There are no restrictions or conditions noted for the donations received during the year.

#### Changes in Accounting Policies

There have been no changes in accounting policies during the financial year.


